MINUTES OF THE NINETY-FIRST MEETING OF THE GOVERNING BODY, HELD AT 10.15 A.M. ON 25 JANUARY 1997 AT THE INDIA INTERNATIONAL CENTRE, NEW DELHI.

The Director informed that Professor S. Gopal has conveyed his inability to attend the meeting. At the request of the Director and other members present, Professor J.S. Bajaj agreed to chair the meeting.

Before taking up the agenda, the Director introduced to the Governing Body Dr. K.J.S. Chatrath, who has recently joined the Institute as its Secretary.

Agenda to be taken up was then adopted and thereafter taken up for discussion.

Item No. 1: To consider the minutes of the Ninetieth Meeting of the Governing Body held at Chennai on 20 December 1996.

The minutes were considered and Item No. 8 as well as Item No. 16 $\,$ of the minutes were taken up for discussion. The Governng Body then took the following decisions:

- Relating to Item No. 8 ("to consider a proposal for introducing short courses at the Institute in the area of Indian Civilization and Culture meant primarily for visitors from abroad"), it was decided to defer consideration of this
- Relating to Item No. 16 ("to note and consider the replies of the Ministry on the various proposals already approved by (ii) the Governing Body") it was decided that:
 - (a) the proposal for setting up of a committee for cadre restructuring may be deferred till the report of the Fifth Pay Commission has been made available;

Item No. 2: To reconsider the Annual Report and the Audited Statement of Accounts of the Institute for the year 1995-96.


The Governing Body considered the Draft Annual Report of the Society for the year 1995-96, including the audited statement of accounts and made the following observations:

- (i) Action should be taken for clearing the pending audit objections, including physical verification of stock of library, and stores.
- (ii) Institute may consider adopting the format of the classification sheet in use in Manipal Deemed University.
- (iii) Last year's figures should be mentioned on the left hand side of the statement against each item for appreciating the position at a glance.
- (iv) Expenditure of Rs. 1.33 lakhs for getting the audit conducted by Accountant General, Himachal Pradesh, was considered high. The Institute may negotiate with the Accountant General for reduction in the audit fee - if necessary, by reducing the number of approved working days - keeping in view the kind of Institute and the type of its activities.
- (v) Administrative expenses should be kept to the minimum. In computing the administrative expenses, overtime allowance/rates, rents and taxes and all other administrative expenses should be considered.

The Governing Body noted with appreciation the achievements of the publication programme of the Institute. This, the members noted, was an indication of the extent to which the Institute was able to reach out to the academic community at large.

The Draft Annual Report, including the Audited Statement of Accounts was approved, subject to taking action on the observations above.

After the above agenda items were completed, with the permission of the Chair, the Director informally introduced the correspondence between the Secretary, Department of Education, Government of India, and Chairman



of the Governing Body regaring exploring the possibilities of shifting of the Institute from Rashtrapti Nivas.

The Governing Body felt that as the letter of the Chairman, Governing Body, Professor S. Gopal, to the Secretary (Education) is still unresponded, no further action is called for by the Institute at this stage.

The meeting ended with a vote of thanks to the Chair.
