The Director sought clarification if the IIAS can use its IC4HD funds for organizing events across countries, applying the UNDP norms. The Committee noted that the IIAS can organize events across countries, as per item no. 5 of the Agreement of Cooperation signed by the IIAS and UNDP for establishment of IC4HD, but it has to be done as per Gol norms if the GOI funds are being used.
